The right of withdrawal will be exercised without having to provide any reasons and without having to bear costs other than those provided for in Article 56, paragraph 2, and Article 57 except as provided by art. 52 paragraph 2 of the same Legislative Decree Pursuant to art. 57 of Legislative Decree 21/2014, if the delivery of the goods took place, the Customer is obliged to return it, intact, to Enagic Italy srl, Via M. Aurelio 35 / a - 00184 Rome, within 14 days from the date on which the Customer has communicated to Enagic Italy srl its decision to withdraw from the contract. Return costs are charged to the customer. The Customer declares to have received the pre-contractual information showing all the points provided for by art. 49 DL 21 February 2014 n. 21 Implementation of Directive 2011/83 / EU on consumer rights, amending Directives 93/13 / EEC and repealing Directives 85/577 / EEC and 97/7 / EC".
